County First Ladies who held a meeting with Pastor Dorcas Rigathi where they deliberated her strategic plan for the vulnerable in the society.

The spouse of Deputy President Pastor Dorcas Rigathi yesterday met the leadership of the 'County First Ladies Association' (CFLA) to strategically advance programs touching the vulnerable across the 47 counties.

They included First Ladies' caucus chair Allamitu Jattani (Marsabit), Saline Barchok (Bomet), Beatrice Sakaja (Nairobi), Dr. Emily Chesire (Baringo), Edna Lenku (Kajiado), Emily Nyaribo (Nyamira), and Rukia Abdinasir (Wajir).

Speaking during the meeting, Pastor Dorcas shared her journey of reaching out to the boy child, widows, orphans and people with disabilities in the last one year since the Kenya Kwanza Government came into office.

She highlighted her visits to the drug dens, streets, and rehabilitation centres to seek the transformation of the boys and men lost in alcohol, drug and substance abuse.

"We decided to sit and talk about the boy child with the county first ladies, and also about our counties and nation, and the condition of drug abuse in the nation. We are accountable. When a mother speaks, the nation listens," said Pastor Dorcas.

"Just like malaria and HIV, we are asking people not to condemn these men in addictions, but to encourage them to become a part of rehabilitation and transformation. Much of the GBV, FGM cases, can actually be addressed when the boy child is parented and brought up the right way," added Pastor Dorcas.

The chairperson of the association said their meeting was an eyeopener into the Office of the Spouse of the Deputy President (OSDP) programs.

"When we heard you (Pastor Dorcas) talk about the boy child, we realized there is a gap, and the boy child issues need to be urgently addressed," said Jattani.

"We are looking to have a bigger meet-

ing with Her Excellency, which shall be inclusive of all spouses of governors in kenya, so she can share with us in a large way, how to support her vision, and we can support her in a big way. We believe in a healthy and balanced community that works together and takes care of the vulnerable, boy child," she added.

She also pointed out the need to demystify the perspective of rehabilitation centres in the eyes of the public, for the facilities to be viewed as sanctuaries of treatment and mentoring.

Jattani also decried the high numbers of widows in the Marsabit and North Eastern parts of Kenya caused by border conflicts that result to death of the men.

Edna Lenku said they were happy with the direction taken by Pastor Dorcas in advocating for the youth. She expressed support for the programs.

"As mothers, led by pastor Dorcas, we shall hold the hands of our youth and walk with them because we love our nation, families and this is a crucial opportunity given to us by God," Mrs Lenku.

"As wives of Governors and County First Ladies, we work with the community. We championed the cause of the girl child and we thank God for its success; but looking back, we see the boy child was left behind, and we must champion this cause," she added.

Pastor Dorcas agreed to work with the First Ladies, their association, and reach the 47 counties to better the lives of vulnerable populations through the programs of the boy child, widows and orphans and people with disabilities, and founded on chaplaincy, outreach and family values.

The event will focus on promoting open trade and resilient supply chains. Miano is committed to building strong diplomatic and trade relations with key global players, highlighting Kenya's role in the African economic landscape. She will also participate in the Japan-Kenya Business Round Table on October 27th, where she will encourage Japanese businesspeople to invest in Kenya. Miano will also highlight Kenya's efforts to enhance trade partnerships and promote local content production in the automotive industry, with 34 parts already considered for production. She will encourage Japanese investors to establish operations in Kenya, leveraging market access to the East African Community market and the African Continent through the African Continental Free Trade Area (AfCFTA) and the European Union.







Gaza Death Toll Passes 5,000 With No Ceasefire In Sight

The number of people killed in Gaza has reached 5,087 according to latest reports, amid intensifying Israeli airstrikes in response to Hamas attacks, while humanitarians repeated urgent calls for a ceasefire and more aid convoys.

Echoing that message, UN health agency (WHO) chief Tedros Adhanom Ghebreyesus issued a new appeal on Monday for "sustained safe passage" for medical essentials and fuel to keep health facilities open.

"Lives depend on these decisions," he insisted on social platform X.

Latest media reports citing the Gaza Ministry of Health indicate that the number of people killed in Gaza since 7 October has risen to 5,087.

Women and children have made up more than 62 per cent of the fatalities, while more than 15,273 people have been injured.

In its latest humanitarian update on the Gaza-Israel crisis UN humanitar-

ian aid coordination office, OCHA, said that more than 1,000 have been reported missing and "are presumed to be trapped or dead under the rubble".

Israel: Threefold rise in deaths

According to Israeli official sources quoted by OCHA, some 1,400 people have been killed in Israel, the vast majority in the Hamas attacks on 7 October which triggered the latest conflict. OCHA said that the reported fatality toll is "over threefold the cumulative number of Israelis killed" since it began recording casualties in 2005.

Trickle of aid

According to media reports a new aid convoy entered Gaza from Egypt on Monday through the Rafah border crossing. This was the third such delivery after the crossing opened on Saturday for the first time since the start of the conflict, following intense diplomatic efforts.

A total of 34 trucks with aid provided by the UN and the Egyptian Red Crescent entered the enclave over the weekend. The UN has stressed that to respond to soaring humanitarian needs, at least 100 aid trucks per day are required.

Desperate need for fuel

The development comes as UN agency for Palestine refugees (UNRWA) warned on Sunday that it was set to run out of fuel within three days, putting the humanitarian response in Gaza at risk.

UNRWA head Philippe Lazzarini said that without fuel, "there will be

no water, no functioning hospitals and bakeries" and that "no fuel will further strangle the children, women and people of Gaza".

Education void

Meanwhile, OCHA said that more than 625,000 children in Gaza have been deprived of education for at least 12 days, and 206 schools have been damaged. At least 29 of them are UNRWA-run establishments.

UNRWA reported on Sunday that 29 of its staff members have been killed in Gaza since 7 October – half of them teachers.

In the occupied West Bank, the escalation has also resulted in restrictions on the access to education. OCHA said that all the schools inside the territory were closed from 7 to 9 October, affecting some 782,000 students. As of last week, over 230 schools which cater to some 50,000 students had not reopened.

JSC Announces Vacancy At Office Of Chief Registrar Of Judiciary



President Ruto Meets With Wigan Ahead Of King Charles III's Visit



President William Ruto yesterday met with the British High Commissioner to Kenya Neil Wigan and other senior officials to discuss King Charles III's Royal visit to Kenya slated for next week.

King Charles III and the Queen are set to visit Kenya from October 31 to November 3rd in a historic visit tracing back in 1952 when Queen Elizabeth II acceded to the throne in the country.

Speaking following the meeting, President Ruto said the visit is a significant opportunity to enhance the collaboration between Kenya and UK in various areas of shared interest

cial nature of our partnership," President Ruto said.

On October 11, the British High Commission in Nairobi said the visit serves as a "celebration of the enduring and warm relationship between Kenya and the United Kingdom highlighting the strong and dynamic partnership they continue to forge." During their visit, the King and Queen will explore Nairobi City County, Mombasa County, and surrounding areas, with a program that reflects the collaborative efforts of Kenya and the United Kingdom.

The visit will focus on areas such as mutual prosperity, climate change mitigation, youth opportunity and employment promotion, sustainable development, and regional stability. While in Kenya, their Majesties will meet with President Ruto, the First Lady, and various members of the Kenyan Government, as well as engage with UN staff, CEOs, faith leaders, young people, future leaders, and Kenyan Marines training alongside

UK Royal Marines.

The King will also participate in an event honoring the life and work of the late Nobel Laureate, Professor Wangari Maathai, alongside Wangari's daughter, Wanjira Mathai.

The visit will underscore the close connections between the British and Kenyan people, particularly in areas such as the creative arts, technology, enterprise, education, and innovation. Additionally, it will acknowledge the more complex aspects of the shared history of the UK and Kenya, including the period of the Emergency (1952-1960). His Majesty will take the opportunity during the visit to deepen his understanding of the challenges faced by the people of Kenya during this period.

Together, Their Majesties will tour a new museum dedicated to Kenya's history and lay a wreath at the Tomb of the Unknown Warrior at Uhuru Gardens, paying their respects to the site of Kenya's declaration of independence in 1963.

President Ruto To Visit Japan In May Next Year

President William Ruto is set to embark on an official visit to Japan in the coming year, reciprocating a visit by Japanese Prime Minister Fumio Kishida to Nairobi in May.

The upcoming visit was confirmed yesterday during a meeting between President Ruto and Japanese Ambassador to Kenya, Ken Okaniwa, at State House Nairobi.

Ambassador Okaniwa delivered a message from Prime Minister Kishida and briefed President Ruto on the forthcoming visit.

President Ruto highlighted the strong historical ties and cooperation between Kenya and Japan, particularly praising Japan's support for various critical infrastructure projects in Kenya

He expressed his gratitude for Ja-

pan's contributions, which have included funding for projects in health, agriculture, education, such as the upgrade of the Kenya Medical Research Institute (KEMRI) laboratory, the construction of the Southern bypass in Mombasa, and the implementation of an intelligent transport system in Mombasa County.

The discussions during Prime Minister Kishida's visit in May encompassed mutually beneficial commercial and economic partnerships, education, scholarships, and infrastructure development, while also addressing regional peace and security concerns, including the situation in Sudan.

Public Participation Held Over Governor Kawira's Impeachment

Heavy police presence was witnessed at Meru Show ground in Gitoro within North Imenti constituency as residents gave their views during public participation in all nine sub-counties on the intended second attempt to impeach the Meru Governor Kawira Mwangaza.

The residents from five wards namely; Ntima East, Ntima West, Nyaki East, Nyaki West and Municipality wards gave their views, some in support of the governor's impeachment while others were against.

According to Ntima West Patrick Kathurima Ntururu who was present said public participation is envisaged in the constitution.

The Notice of motion to impeach Governor Kawira was tabled at Meru County Assembly on 17th October 2023 by the leader of Majority Evans Mawira.

MCA Ntururu said all reports by the members of public will be included

in the report which will be compiled by the county assembly technical team Tuesday and that the Impeachment motion will be debated on Wednesday the 25th, October 2023.

He said after debating the impeachment motion at the county assembly, the MCAs will vote either for or against the impeachment. If the governor is impeached, the speaker of the county assembly will have 48 hrs to write to the speaker of the Senate an impeachment report.

MCA Ntururu said after the speaker of the Senate receives the impeachment report, then he will organize for a Senators' house meeting.

After agreeing whether to debate the report in full house or as a committee of the house the senators will have 10 days to come up with a report adopting the MCAs decision to impeachment or not.

Accusations

While tabling the notice of motion Tuesday 17th October, the Majority leader Evans Mawira outlined seven grounds on which the Assembly intends to impeach Mwangaza.

The MCAs have accused Mwangaza of misappropriation and misuse of county resources by withdrawing county funds under the guise of paying for various supplies by the Governor's relatives who are not eligible to bid for contracts.

Mwangaza is also accused of nepotism. The MCAs alleged that the Governor appointed one Edwin Mutuma Murangiri (her husband's nephew) as the CEO of Meru Youth Service and Acting Chief Officer, Ministry of Finance.

The MCAs further accuse Mwangaza of bullying, vilification and demeaning other leaders in the public. Illegal appointments and usurpation of statutory powers, contempt of court, illegal naming of a public road after her husband and contempt of the Assembly are also some of the accusations labelled against the Governor.

Court Orders Review Of Programming Code For Broadcasting Services

The High Court has annulled the decision of the Communication Authority that censored six local TV stations for covering opposition demonstrations on the 20th of March this year.

The directive issued on the 22nd of March targeted KBC, TV47, Citizen TV, NTV, K24 and Ebru TV after the then former Communication Authority boss Ezra Chiloba accused the media houses of contravening broadcasting regulations.

"....section 46A (k)of the KICA implores the Authority to ensure compliance with broadcasting regulations and monitor compliance with broadcasting media standards as well as Regulation 19 1 (c) and (d) of KICA Broadcasting regulations, 2009 which require a licensee of broadcasting services to ensure that no broadcast by its stations glorifies violence or depicts violence in an

offensive manner; or is likely to incite, perpetuate hatred, vilify any person or section of the community." Chiloba had argued while making the decision.

In a ruling by Justice John Chigiti, the court said regulation 19 (a)(b)(c) and (d) of the Kenya Information and Communication (Broadcasting) regulations, 2009 unconstitutionally limits the freedom of expression, media and information in vague and overbroad terms contrary to article 22,34 and 35 of the constitution.

Justice Chigiti further ordered that the programming Code for Broadcasting Services in Kenya ,2019 has expired and is of no legal effect under 46 H (2) (b) of the Kenya Information and Communications Act, 2009 and section 11(1) and (4) of the statutory Instruments Act, 2013 as a result of which clause 10.2.1 of the programming code does not sustain the Communications Authority's decision.

The court has issued an order compelling the Communication Authority to review the programming code for Broadcasting Services in Kenya, 2019 under section 46H (2)(b) of the Kenya Information and communication Act 2009.

A few days ago, President William Ruto led the nation in marking this year's 60th Mashujaa day cerebration.

In his speech, the head of state once again fired a stern warning to public servants and state officers who were contemplating stealing and looting the taxpayers' money.

He noted that billions of shillings will be allocated to run Universal Health Coverage (UHC) which he had just unveiled.

A huge of these monies will come from your pockets, your monthly contributions.

The national and county governments will also allocate more funds to power this noble initiative.

Some of the officers entrusted to manage these funds might think an opportune time of stealing and lining up their pockets have arisen. This is the time of eating.

My fellow Kenyans, take this from me, I will be hard very on them. It will never happen, Dr Ruto further stated.

For the first time, Kericho county hosted the Mashujaa day cerebration which was held at the main Green Stadium in Kericho town.

This was in line with the spirit of furthering the course of the new constitution that was promulgated in 2010.

The decentralization of public resources, programmes and services had stood out as one of its key pillars. This heralded in birth of 47 county governments.

He spoke as some 8 current and former governors were battling charges of corruption, economic sabotage and abuse of office in court.

This reminded me of what happened in Nigeria when the devolution was introduced. The pioneer county bosses thought that it is time to eat.

Little did they know that then President was a non-nonsense man. He was committed to walk the talk in slaying the dragon of corruption. He left half of them in jail when he retired.

Since he assumed office, President Ruto has remained consistent and focused in these endeavours. He always escalated the matters by calling on the heads of the anti-graft bodies to live up to their oath of office. There are no sacred cows in my government. You have my full support.

Turning to elected leaders, he always reminded them that they were not above the law. You must be accountable to the electorates. If not, you are not worth to be called leaders. They did not elect you to steal their resources.

The President's interventions have been resonating very well with the masses because this signaled a radical departure from Uhuru Kenyatta's presidency.

Uhuru was known for talking tough but without taking any tangible action.

There was a time he said that Sh2 billion was being stolen every day in Kenya but this matter ended there.

The head of public service Felix Koskei announced a few days ago that Ruto administration is in the process of setting an inquiry to look at this matter. As of now, we cannot tell whether what the former President said is true or not. Koskei further stated that a donor have agreed to fund the inquiry.

Having said this, I want to assure Kenyans that President Ruto is committed to win the war against graft. You can take this to the bank. Koskei, the head of public service spoke at the Bomas of Kenya where he was hosted by the civil society organizations involved in the fight against.

Back to Uhuru, he had earlier shocked Kenyans when he hosted the heads of anti-graft bodies at State House Nairobi.

Though one would have expected him to take on them for frustrating his administration's efforts to fight mega corruption scandals, he instead appeared helpless as he threw his hands in air. He posed: What do you want me to do? Kenyans interpreted this to mean they were on their own.

President Ruto again took a bold move when he thwarted a plot to steal Sh3.7 billion from the Global Fund earmarked for purchasing and supplying mosquito nets to tens of thousands of downtrodden Kenyans.

He fired the senior officials at the Ministry of Health and Kenya Medical Supplies Agency (KEMSA) who had been adversely mentioned.

He also called for the prosecution of the culprits.

The other day we saw Koskei unveiling a raft of measures aimed at streaming the water works sector.

At Athi Water Works Development Agency, he announced the cancellation of the contract of the Chief Executive Officer and anti graft bodies to commence investigations against him.

At KFS, President Ruto endorsed the decision of the board to sack and send 29 managers and forest rangers packing. Those culpable should face the law. At this juncture, allow me to turn to the narrative of Ruto's well known critics. They wanted Kenyans to believe that there was nothing to be proud of. Corruption is rife and President Ruto is just 'watching'. He is doing nothing to reverse the trend.

The top leadership of the opposition Azimio La Umoja-OKA coalition is the leading peddler of these claims.

The coalition is yet to prove these claims despite receiving a strong backup from a section of the mainstream houses championing their course. The claims by Azimio leader Raila Odinga and his brigade were mainly politically motivated and geared towards settling political scores. Raila never believed that he can lose elections to Dr Ruto.

This is because he was enjoying the support 'Handshake' partner President Uhuru Kenyatta. This is the first time he enjoyed the backing of the outgoing President.

In yester years, Azimio leader Raila Odinga had curved a niche of being a whistleblower. He had indeed become a household during the reign of President Mwai Kibaki and his successor Uhuru Kenyatta.

He had unearthed and exposed a number of mega corruption scandals.

But one thing remained clear. He would play this role when he was fighting and pushing these governments to succumb to his demands.

Once he had fought his way and occupied his seat at the high table where the national cake is being shared, he always become contented. He would no longer blow the whistle.

We know today he is harboring a major grudge with the current government of President Ruto.

As such, he could have been in forefront of exposing the so called corruption scandals if they ever existed.

He would not dare to do this. Reason? He knew he would end up being embarrassed and ashamed because of peddling outright lies.

But many Kenyans believed those cooking these stories fully enjoyed his blessing.

Reason? This card was helping him to further his political course. By painting him in bad light, he hoped this would make Dr Ruto soften his stance and invite him for talks.

It has dawned on him that Dr Ruto is a hard nut to crack. He cannot succumb to these tricks designed to blackmail and intimidate him.

For now, Raila's latest remarks and body language points to this. He wants to make peace with the President. Has realized this when it is too late?

He has been desperately looking for an opportunity to have one-on-one meeting with President Ruto.

It worth noting. Raila lost the election to Dr Ruto. After being declared the winner by the IEBC chairman, Raila filed a petition at the Supreme Court of Kenya to challenge his victory. He lost the case and the court upheld the Dr Ruto's victory.

Also, Wiper leader Kalonzo Musyoka confirmed this when he spoke in Machakos during the Saba Saba demonstrations. He stated. Our eader Raila Odinga lost but Ruto won with a slight margin of 60,000 votes. This explains why the country is divided in the middle. We therefore call upon Ruto to respond to our calls for dialogue.

With this, President Ruto does not owe Raila any debt.

While addressing the Committee Chrispine Juma CEO of the lake region water agency highlighted on the issue of whether the Central Rift water works development agencies are obligated to perform task at the lake region, a matter that has brought confusion on their mandate within the region.

The Lake Victoria South Water Works Development Agency, is one of the nine Water Works Development Agencies, established in the new Water Act 2016. The Agency is currently under the Ministry of Water, Sanitation and Irrigation, covering 8 counties of Bomet, Homa Bay, Kericho, Kisii, Kisumu, Migori, Nyamira and Siaya.

"Am concerned with the matter where like in our case the Central Rift Water Works development Agencies is implementing projects in our area of jurisdiction of which we don't have any mandate and oversight on"Stated CEO Chrispine .O. Juma

On the other hand Kisumu senator Prof Tom Ojienda questioned on issues of county owning the water projects done by the agencies and the transfer of assets to the county water companies when handing over is being partaken.

According to the Chair Cavince Odoyo from Lake Victoria South Water Works development Agencies, the Agency since 2019 was covering an area of jurisdiction with about 8.8million people and has enough water to supply UpTo 2030.

However the committee chair senator Osotsi has commended the agency on its mode of organization

Fury v Usyk and Anthony Joshua v Wilder could become double bill in April

Anthony Joshua says his fight with Deontay Wilder could be part of a sensational double bill with Tyson Fury's bout against Oleksandr Usyk.

Champions Fury and Usyk agreed a deal in October for a historic undisputed heavyweight fight, set to take place in Riyadh, Saudi Arabia.

"They want to put Usyk-Fury, Joshua-Wilder on the same night. That might not happen until April," Joshua told BBC Sport and other outlets on the sidelines at the US Grand Prix in Austin, Texas on Sunday.

Former two-time world heavyweight champion Joshua has been heavily linked with a fight against hard-hitting American Wilder, with his promoter Eddie Hearn previously saying "we've agreed the money, we've agreed everything".

But that fight fell through and no contracts were ever signed between the two parties.

Fury, 35, must first come through uninjured in a non-title bout against MMA star Francis Ngannou on Saturday in Riyadh. "When Fury gets through Ngannou, it is going to be late Octo- intended date of 23 December.

ber, early November, so I doubt he will now prepare for Usyk and fight in December, it's too short," said Joshua.

"So the next window will probably be in March-April, so that's probably when the undisputed fight will potentially happen.

"Then obviously what we are being told is they want to make it a mega card and they like the sound of Joshua v Wilder on the same card as well."

Briton Fury is the WBC champion and Ukraine's Usyk, 36, holds the WBA, WBO and IBF titles.

The winner will be crowned the first undisputed heavyweight champion in the four-belt era.

Fury has won 33 fights with one draw since turning professional in 2008, while Usyk - who has won all 21 professional bouts defended his titles against Londoner Daniel Dubois in August.

"The heavyweights always spark the imagination of the fans, and I have no doubt this will be the biggest boxing event of the century," Fury's promoter Frank Warren said in September when the fight was announced, with an

The four fighters have, along with the retired Wladimir Klitschko, dominated heavyweight boxing for the past 15 years and their careers are intertwined.

Fury won his first world title after dethroning Klitschko in 2015, before taking a hiatus from the sport.

After well-documented issues with mental health, he returned more than two and a half years later. He contested a trilogy with Wilder and, having drawn the first fight, beat the American in 2020 to become WBC champion. Fury won the third fight with hard-hitting Wilder and has since defended his belt against Britons Dillian Whyte and Derek Chiso-

Usyk is one of the most decorated fighters in world boxing. The London 2012 Olympic gold medallist became undisputed world champion before dethroning Briton Joshua in 2021.

Joshua has picked up two victories this year, over Jermaine Franklin and Robert Helenius, following consecutive defeats by Usyk as his previously dominant career hit a roadblock.

In a phenomenal rise to stardom,

2012 Olympic gold medallist Joshua became world champion in his 16th fight, knocked out his first 20 opponents and unified the division in his 21st outing.

Between those events, he defeated Klitschko in 2017 in the Ukrainian's final bout in one of the greatest fights of all time.

Wilder, who turned 38 on Sunday, held the WBC heavyweight title from 2015 to 2020, making 10 successful defences.

He has only fought once since the second of his two losses to Fury, in October 2021, beating Helenius in the first round a year

Joshua said he plans to fight in December "in London, probably [at] the O2 or Wembley Arena" against an unnamed opponent, before taking on Wilder.

"For an event, that's good [the potential double bill], but for a career, I've got to stay busy," the 34-year-old said. "So in terms of opponent, we have to find the right opponent. I'm switching trainers. I am following my process."

Joshua later clarified that he meant "switching" to different working styles with different trainers before he goes into full training camp, rather than switching to a new trainer.

He added: "I remember when they said they didn't want me to fight this year. They were like, don't fight this year, we're going to do the Usyk-Fury fight. Imagine like I fought twice this year already, I would have had a stagnant year again.

"So I am just following my process, I am not listening to all the noise about Wilder and these guys. When the opportunity comes, we will be ready, because I will have trusted where I'm going and it will have led me to the fight, but I am not waiting around for big opportunities."
