



Kenyan Investor Raises Alarm Over Changing Banking **Trends On Borrowing**

In a surprising twist within Kenya's banking sector, a notable shift is underway as financial institutions increasingly target guarantors rather than primary borrowers when loans face default.

This departure from conventional practices has ignited concerns, sparking fears about its potential repercussions for borrowers and those who stand as guarantors.

Financial Expert Nazir Jinnah yesterday said traditionally, guarantors played a secondary role, intervening only when the primary borrower defaulted.

"This approach was considered a last resort, with banks exhausting all options with the borrower before turning to the guarantor," Jinnah pointed out in a statement.

"A discernible change is underway, with reports indicating that certain Kenyan banks are actively pursuing guarantors, even when primary borrowers possess the financial means to repay."

For example, he pointed out the case of English Point Marina which has suffered the fate of the worrying

He said that English Point Marina was the primary borrower at the Kenva Commercial Bank (KCB), while Pinewood Beach Resort and Spa was its guarantor.

The bank has since put English Point Marina under receivership while a legal suit is underway challenging its intended takeover of Pinewood Beach Resort and Spa.

English Point Marina is owned by Amin Kanji, his wife Leila, brother Alnoor, sister-in-law Nafisa and Nazir Jinnah. The luxury property is located by the harbour and consists of 96 apartments, eight penthouses and

a 26-room hotel.

It is one of the few private projects granted the Vision 2030 Private Sector Flagship status.

This shift, Nazir Jinnah said raises questions about the underlying motives and the potential consequences for both borrowers and guarantors.

He cautioned that the new shift towards guarantors could erode trust between banks and primary borrowers, who may feel unfairly targeted, especially if they have the means to meet their obligations.


Going forward, he said prospective guarantors, "may become more cautious, knowing that banks might swiftly turn to them in case of default. This could impact the willingness of individuals to provide guarantees for

"Striking the right balance between risk mitigation and fair treatment of borrowers and guarantors is crucial for maintaining a healthy and sustainable banking environment."

He added that, "as this trend unfolds, stakeholders, including regulatory bodies, banks, borrowers, the Central Bank of Kenya and guarantors, must engage in meaningful dialogue to ensure that the interests of all parties are adequately protected."



The development of the EAC NTBs APP was funded by the Netherlands through TradeMark Africa (TMA).

The EAC NTBs App, seamlessly blending SMS, email, and phone reporting methods, offers economic operators a one-stop solution for effectively reporting Non-Tariff Barriers to trade. By streamlining the NTB reporting process, the App will aid traders and producers in tackling obstacles that impede their trade efficiency and competitiveness. Additionally, it ensures transparency and quick resolution of issues by engaging technical and policy-level mechanisms, such as National Focal Points, the National Monitoring Committees (NMCs) and

the Regional Monitoring Committee (RMC).

Speaking during the launch of the App, EAC Deputy Secretary General in charge of Customs, Trade and Monetary Affairs, Ms. Annette Ssemuwemba said the EAC NTBs App marks a pivotal moment in creating a smooth trading environment across the EAC region.

"We are dedicated to eradicating the barriers that impede economic growth, and integration. This innovative solution serves as a powerful tool to empower traders, producers and economic operators offering them with a unified platform to promptly address and resolve NTBs," she added.

"At TradeMark Africa, we believe in fostering a vibrant and conducive trade environment that propels economic growth and regional integration. NTBs pose a major problem for traders and producers, as they can reduce profits and limit market access. NTBs include issues that can hinder trading effectively such as discriminatory requirements for special licenses and permits, excessive paperwork, complicated customs procedures, and bureaucratic delays at borders.

A recent EAC Regional Meeting Committee (RMC) report (2023) estimated the direct costs of NTB's at USD16,703,970 and total trade impact at USD94,918,000 decreasing trade by an average of 58%.

However, since 2017, EAC has re-

solved 89.5% of the reported NTBs (EAC Time Bound Programme report, 2023). In addition, there has been a relatively steady decrease in reported NTBs. In recent years, from 2021 to 2023, the number of reported NTBs complaints has remained stable, ranging between 8 and 11 cases annually with a significant improvement in the resolution of NTBs reported to an average of 88.3 days. Between June 2022 and June 2023, a total of 16 NTBs complaints were reported within EAC. Out of these, 9 NTBs have been resolved while 7 complaints remained in progress. A significant number of NTB complaints were addressed (56.25%) and resolved within the given timeframe. However, a notable portion of complaints, specifically (43.75%) were still in progress by end of June 2023. The EAC NTBs App allows the users to report the complaints in one of the three (3) EAC official languages;

ers to report the complaints in one of the three (3) EAC official languages; English, Swahili and French and can be downloaded from the Apple Store, Google's Play Store, and other Android devices.

The additional funds will also cater for school feeding programmes, especially in drought-stricken areas.

"This will check drop-outs, boost enrollment and further the Government's efforts to increase literacy," said Majority Leader Kimani Ichungw'ah.

The Act also increases CDF allocation on environmental activities from two per cent to five per cent to fund for climate crisis.

Besides that, it introduces a three per cent allocation of the Fund for Constituencies' digital hubs.

The hubs, the Government observes, are key in enabling the youth to acquire skills to boost their employability.

Meanwhile, the President also assented to the National Lottery Bill (National Assembly Bill No. 69 of 2023)

This paves the way for the establishment of the National Lottery Board that will administer the newly-established National Lottery.

The Board will be tasked with the supervision, control and monitoring of the operations of the National Lottery.

It will also be mandated to erect measures to prevent fraud in the conduct of the National Lottery.

Ichungw'ah, who sponsored the Bill, said the goal of the conduct of the National Lottery is to fund social development in the country.

Deputy President Rigathi Gachagua, Speaker of the National Assembly Moses Wetang'ula, Attorney General Justin Muturi, Solicitor General Shadrack Mose, among others, were present.

Murkomen Reads Sabotage In Yet Another Blackout At JKIA

Roads, Transport and Public Works Cabinet Secretary Kipchumba Murkomen has said the ministry will be seeking a formal request to the National Police Service to begin investigations after another power blackout hit the Jomo Kenyatta International Airport on Sunday evening.

The blackout that affected most parts of the country is said to have affected terminal 1A and 1E despite the immediate changeover of power to standby generators at the facility.

"Considering the frequency of the power disruption, and taking into account the fact that JKIA is a facility of strategic national importance, we are making a formal request to the National Police Service to investigate possible acts of sabotage and cover-up," Murkomen sad via his official

X handle.

The Sunday blackout was the second major power outage in the country in a span of one month.

According to Kenya Power, the blackout affected Mt Kenya, South Nyanza, Western, Central, Rift, North Rift, North Eastern and most parts of Nairobi including JKIA. However, the firm said by 2AM Monday, it had restored power in most of the affected areas.

"Over the past week, our generator system at JKIA has undergone rigorous testing to ensure continuous and reliable power supply. Despite these efforts, during tonight's power outage, two of our generators, specifically those serving Terminals 1A and 1E failed to immediately activate," said Kenya Airports Authority (KAA).

Murkomen has further directed KAA Board and management to fully implement the reform agenda as advised in the report by the technical committee.

The latest media report have indicated that President William Ruto have hatched a plot to clip the political wings of Attorney General (AG) Justin Muturi and Speaker of National Assembly Moses Wetangula.

After reading the story, this was my conclusion. It was not based on any iota of truth and evidence.

The authors seems to have had relied on usual rumors, propaganda and outright lies being peddled by the wellknown critics of the President.

The President had nothing to do with that proposal.

For starters, it is one of the proposals contained in a bill drafted by the majority leader Kimani Ichungwah. The law requires him to table the bill before the house for debate.

If approved, that is when the President comes in. He will have two options: sign it into law or return it back to parliament with memorandum explaining the reasons for doing that.

The ODM had argued that the due process had not been followed to the letter and spirit.

The parastatals are owned by the people of Kenya. So, this is a weight matter. You cannot sell them without involving them

In earlier statements, Raila and other party luminaries had pointed an accus-

ing finger at President William Ruto.

The President is fully behind this move and he is working with Treasury Cabinet Secretary.

The Azimio brigade would not point out sections of laws that the President had violated.

As the law required, the Treasury Cabinet Secretary organized public forums during which public views were collected and collated. The views were factored in privatization bill.

I would have expected Raila to do two things if he didn't not agree with Bill. First, mobilize his Azimio troops to reject the bill on floor of parliament. If he fails to marshal enough numbers, move to court immediately after the President assented to it.

He failed to do this. With this, his decision to move to court is being interpreted as an afterthought.

The question is. What prompt him to change his mind? Many avers it is not because of Wanjiku's interests but rather his personal interests.

Since the law was passed, a section of the leaders in the minority side had been making noises at the funerals, church pulpit, homecoming parties. Why wait until when the government starts to actualize this law?

It therefore means they were contented. The decision to move to court had been preceded by Raila's remarks four days earlier. Are you ready to go back to the streets? Raila asked a crowd in Nyamache, Kisii county, where he attended the homecoming party of Governor Simba Arati. Then, wait for my whistle. We all know that Raila's political game plan is to continue engaging President William Ruto in a smear campaign.

This is not because the President is not doing his job of serving Kenyans, it is because he is yet to shed off misplaced and warped thinking that Dr Ruto stole his victory.

Raila was the candidate of the outgoing government. Dr Ruto was an outsider. So, how did an outsider stole your victory?

In light of this, this is my considered

view. If he make good his threat, Raila's game plan would fail miserably.

Why I would not expect his supporters to heed his call to participate in demonstrations?

He failed to try organize protests when President Ruto assented to the Bill.

His turnaround is suspect. The other day I heard a group of the people in the estate saying.

Raila was angling himself to play the role of a big broker in the privatization of some of the entities. He knew he would mint millions of shillings. It seems he has been elbowed out.

He is pursuing selfish and personal interests. Therefore, we cannot put our lives in danger for a course that has no bearing to public interest.

He used us last time. A fool has now become clever. He will be in for a rude shock.

It is worth to recall that during the electioneering period, Dr William Ruto, the presidential candidate of United Democratic Alliance (UDA)/ Kenya Kwanza, kept reiterating.

If I win the elections, I will give priority to the privatization of loss making State Corporations and Parastatals plus those that had already collapsed and shut down.

The leadership of the previous governments fully bore the brunt.

They just watched helplessly as these state entities crumbled down due to four main reasons: High levels of corruption, mismanagement, laxity and don't care altitudes. These vices would be committed by big fish entrusted to manage them

To make the matter worse, the previous governments resorted to bailing out the entities.

Billions of shillings of taxpayers were being pumped but none of them will get back to its feet. Kenyans would not get value for their hard-earned monies. As such, they would end up being the biggest losers.

For Dr William Ruto, he had conceived a workable plan which would be a game-changer in terms of changing this narrative. God heard his prayers and he won the elections.

The Privatization Bill originated from the cabinet in line with the rule of collective responsibility.

This reaffirmed the commitment of President Ruto to walk the talk. This is in terms of following the dictates of the constitution and law to the letter and spirit.

The Finance Bill 2023 passed by parliament listed the 11 entities which are earmarked for privatization.

Reason? The political class played a key role in the appointment of the chairpersons and chairmen of these State Corporations.

Kenya Cooperative Creameries (KCC), Kenya Meat Commission and pyrethrum Ginneries were among profit making factories that had already collapsed. The loss making ones were: Kenya Airways, Mombasa Port, Kenya Pipeline, Kenya Seed Company, National Oil Cooperation among others.

Once advertised, the bidders' history should be thoroughly scrutinized.

The two main considerations should be. First, the proprietors of the firms that qualify have the interest of the Kenyan people at heart.

Secondly, the investors have success stories of managing and turning around the fortunes of similar entities that had been run down by the state.

You would expect the multinational companies to buy some of the State Corporations.

For them, their success stories would go beyond the border.

Besides, the government would be expected to review the tax regime and enact laws that will attract both local and foreign investment.

As I conclude, allow me to say this. The good thing with privatization is that this creates room for competition.

So, the new owners will work very hard. This is because they want to make profits out of this. They know the Kenya government will also collect a huge chunk of monies as taxes.

Again, if the entity collapses, they will become the biggest losers. They will not only lose the capital but also the assets which they had acquired through hard work and sweat.

To avoid these pitfalls, I'm sure they will manage the entities in a professional, disciplined and precision manner.

Achievements In The Field Of Science, Literary Environment And Art In Bukhara During The Timurid Era

The construction and improvement works carried out during Ulugbek's time required the preparation, education and training of architects who had mastered the engineering and technical capabilities of that time.

In order to build large and state-important structures, the integrity and financial capabilities of the central government should be high. During Ulugbek's time, architects such as Zayniddin bin Shamsuddin showed enthusiasm in building structures of state importance. Ismail bin Tahir Isfahani is mentioned in the sources as the architect of the Ulughbek madrasa in Bukhara.



His grandson Mirzo Ulugbek, who imitated Amir Temur in the spheres of state and social management, is distinguished by his great contribution to the development of science in Movarounnahr. During the Timurid period, Naqshbandism became a political force and took root among the broad strata of society, it was natural for religious fanatics to oppose the rule of Mirzo Ulugbek. Dervishism first spread widely in Bukhara. The fact that Mirza Ulugbek even built a madrasa in Bukhara earlier than the capital of the kingdom, Samarkand, shows that he paid great attention to the promotion of secular knowledge in Bukhara. Because, during Ulugbek's time, madrasahs mainly promoted book sciences. Dervishism did not recognize other than religious books. In particular, he did not recognize book sciences. Mirzo Ulugbek well understood that this would lead to one-sided development and, ultimately, backwardness in the society. For this reason, he built a madrasa in Bukhara and aimed to promote and develop worldly sciences. With the above opinions, we are far from the opinion that Mirzo Ulugbek is against religious knowledge. There are a lot of historical facts and evidence that he mastered religious knowledge, including jurisprudence. This caused Ulugbek to become famous among the broad strata of the society due to his knowledge and fairness. His wisdom in jurisprudence surprised even the scholars of his time in this field. As an example, "Sharh ala al-fiqh, al-Akbar" - "Commentary written on the great jurisprudence" written by Alauddin al-Bukhari (850/1447) on the work of Abu Hanifa al-Noman bin Thabit bin Zu (150/767) The fact that it is dedicated to Ulugbek is enough to justify our above opinion.

It is not necessary to prove that special knowledge and skills are required for the construction of huge structures with complex architectural solutions. The construction and improvement works carried out during Ulugbek's time required the preparation, education and training of architects who had mastered the engineering and technical capabilities of that time. In order to build large and state-important structures, the integrity and financial capabilities of the central government should be high. During Ulugbek's time, architects such as Zayniddin bin Shamsuddin showed enthusiasm in building structures of state importance. Ismail bin Tahir Isfahani is mentioned in the sources as the architect of the Ulughbek madrasa in Bukhara. It should be noted that the buildings built by Ulugbek in Samarkand and Bukhara completely repeat the traditions of the time of Amir Temur. They embody the traditions of Eastern architectural monuments and reflect artistic value and technical excellence. In order to create such structures, a geometric solution, high artistic taste and knowledge were necessary. Ulugbek tried to turn the cities of Movarunnahr, such as Samarkand and Bukhara, into centers of knowledge. By his decree, madrasas were built in Bukhara in 1417, in Samarkand in 1420, and in Gijduvan in 1433. Madrasahs built in Bukhara and Gijduvan were built not only as educational institutions, but also for the purpose of beautifying cities and villages and forming infrastructure. Special buildings for madrassas began to be built, the largest madrassas were built by rulers, large landowners, religious leaders. Usually, on the facades and doors of madrasahs, verses of the Holy Qur'an calling for learning or invitations of Hadith are written with patterns. For example, on the facade of the madrasa built by Mirza Ulughbek in Bukhara, the Qur'anic verse "Talab ul ilma farizatun, ala khuli Muslimin wa Muslima", that is, the demand for knowledge, is a duty for every Muslim man and woman. It should be emphasized that although Ulugbek built madrasas in Samarkand and Bukhara, he could not improve his relations with the religious. Ulugbek's relationship with his sons, military defeats contributed to the disintegration of the Timurid kingdom and its destruction.

Along with religious sciences, great attention is paid to the teaching of secular (biblical) sciences in madrasahs. According to the classification of the sciences taught in madrasahs, the level of teaching, and the position of the teachers, they are divided into two levels: a general educational institution, that is, it is called a madrasah. In these madrasahs, the scientific and religious sciences are taught in depth, at the same time, the basic sciences of mathematics, geometry, astronomy, medicine, history, geography, we can see that it is organized by the Arabic language. Scholars with high scientific careers worked in madrasahs, such madrasahs were mainly located in central cities, such as Sa-

markand, Bukhara, and Herat, where science and culture were developed. In the Middle Ages, madrasahs in Movarounnahr and Khorasan became the main center of the spiritual life of the society. Their graduates have almost completely satisfied the demand for handwritten literature, scientific and popular treatises. History, geography, Muslim law, Arabic grammar, Qur'an commentaries, poetry, ethics, logic, mathematics, astronomy, medicine - all these subjects formed the subjects within the framework of education in the madrasa.

The beautification of the country, the construction of magnificent structures, and the repair of old ones began already during the reign of Amir Temur, and during the reign of Amir Temur in Bukhara, such structures as Chashmai Ayub, Mag'oki Attori, Namazgoh were renovated and their surroundings were beautified. Some historians also cite the opinion that the architectural complex of the Kalon Mosque in Bukhara was built by Amir Temur and got its current appearance during the reign of Shaybani Abdullah Khan. As a result of the conducted research, the Kalon Mosque was built on the site of a destroyed building in the 13th century. As a result of the archeological researches carried out by two excavations, it was found that the Kalon Mosque was built at the end of the 14th century. This corresponds to the era of Amir Temur. The year 1514 is mentioned in the literature as the date of the complete completion of the structure, and it is mentioned that it is artistically characteristic of the Timurid period.

The development and implemen-

tation of educational technologies

as a scientific problem envisages conducting special scientific and pedagogical research. It should be noted that educational technology as a research object of pedagogy is not only a method of teaching specific subjects, but also requires a new approach to teaching social sciences. In this regard, it is worth noting that technology is is a process that leads to a quality change in the subject as a result of the effect shown by the subject on the object. Technology always provides for the execution of purposeful actions directed at the object in a certain sequence, using the necessary means and conditions. Pedagogical technology (PT) is a social phenomenon that, as a result

of the teacher's systematic influence on students with the help of teaching tools, intensively forms predetermined social qualities in them, necessary for society. Since pedagogical technology is a social necessity, it first appeared in the USA in the 70s of the 20th century, and later it was widely used in the educational process in other developed countries.

After gaining independence, scientists of Uzbekistan began to establish economic, social, political and scientific-educational relations with foreign countries. As a result, advanced and effective technologies began to enter our country. Along with this, the concept of progressive pedagogical technology in the world has also entered. V.P. Bespalko, one of the first among the CIS countries, described the need to introduce pedagogical technology into the educational process:

"PT is a project of the process of forming a student's personality, which can guarantee pedagogical success without depending on the teacher's skills." V. M. Monakhov, one of the Russian scientists, gives a brief definition that "PT is a system of orderly actions that lead to pre-planned results and must be performed", and draws attention to its main features. According to his definition, "PT-technologies the educational process, increases its reproducibility and the stability of the pedagogical process, and frees it from the subjective characteristics of the executor of this process.

"According to M. V. Klarin, PT is the design of the educational process based on predetermined target indicators with a technological approach to the educational process. According to Uzbek pedagogic scientists Nurali Saidakhmedov and Abdurakhmon Ochilov, PT is the process of intensive formation of predetermined personality qualities in them as a result of the teacher's use of teaching tools to influence certain conditions on students. Pedagog scientist B.L. Farberman defines pedagogical technology as follows: PT is a new approach to the educational process, and social engineering in pedagogy is an expression of consciousness.

It is a social phenomenon related to making the pedagogical process a standard based on technical capabilities and human technical thinking and creating its optimal project. In order to compare these definitions with the definitions given far abroad, we will quote the definition given by the Japanese pedagogue scientist T. Sakomoto:

PT is the introduction of a systematic and complex way of thinking into pedagogy, in other words, a certain pedagogical process according to the definition of UNESCO, one of the authoritative agencies of the United Nations Organization, "PT is the design and implementation of the entire educational process, building technical and human resources in an

While the systematic approach is mentioned in the definitions given by the scientists of the CIS to PT, it can be seen that it was completely forgotten when the project of the educational process was being drawn up, and the laws and regulations of the principle of the systematic approach were not followed.

Indeed, for a person who knows well the principle of a systematic approach to objective existence, as Sakomoto says, the concept that "PT is bringing the educational process to a certain system" is enough.

Through this concept, it is possible to understand all other features of PT, that is, it is goal-oriented, it consists of several interrelated parts, and others. Because all these properties, according to the theory of systems, are integral qualities of things and phenomena called systems.

The new concept of acquiring knowledge in the current educational system requires the use of various methods of modern pedagogical technology. The educational process is a system. Its constituent elements are the educational goal, the expected result, the teacher, the student, the content of education, the method of education, the form of education, educational tools, control and assessment.

When designing the educational process, the above elements should be selected correctly. The introduction of pedagogical technologies in the educational process leads to the activity of the teacher as an organizer or consultant. This requires the qualities of independence, creativity and willpower from the student and the teacher.

Innovation (English innovation) means innovation. Innovative technologies are the introduction of innovations and changes to the pedagogical process, the activities of teachers and students, and reasonable interactive methods are used in its implementation. Interactive - ("Inter" is mutual, "act" - to act) is to act mutually. This is the uniqueness of the methods is the joint activity of the teacher and the student. The process of pedagogical cooperation occurs:

- 1. The student will not be indifferent during the lesson; he will go to independent thinking, creativity and research.
- 2. Continuity of the student's interest in science during the educational process is ensured.
- 3. The student approaches the problem independently.
- 4. Continuity of the cooperative activity of the teacher and the student is ensured.

Pedagogical technology in the educational process is a coherent process in a clear sequence, it is a pedagogical process aimed at providing a goal-oriented, carefully planned and guaranteed result based on the needs of the student (teacher).

A teacher fulfills the social task of the society, prepares mature specialists. For this reason, the teacher must meet socio-political, pedagogical and personal requirements. Also, he believes in the name of independence, has comprehensively developed scientific thinking, has professional knowledge, is a deep expert in his field, master of pedagogical skills, has acquired pedagogical, psychological and methodological knowledge and skills, and has the ability to exert pedagogical influence.

Should have the ability to choose the most appropriate methods and tools. The process of pedagogical formation of a special subject teacher begins with the process of education at a higher educational institution. In the educational plans and programs of higher education institutions, the role of general technical sciences is important in teaching the secrets of this profession to the teachers of future labor education and providing scientific knowledge.

General technical sciences serve to ensure technological readiness of labor education teachers. No matter how skilled a teacher of labor education may be, if he does not master technical and technological sciences well, he will not succeed in his work. Because the professional activity of a teacher of labor education is closely related to his technological training. That is why technical and technological sciences are of great practical importance in the system of training teachers of special subjects.

Conclusion: An effective solution to the problem of personnel training is, first of all, a professional who has deep knowledge of the fundamentals of psychology, pedagogy, economy, ecology, culture, law and other similar disciplines, who can meet today's requirements, and who has comprehensive knowledge. It is related to teacher training.

Ten Hag Under Scrutiny As Man Utd Fight For Champions League Survival

Manchester United's future in this season's Champions League hangs by a thread ahead of Bayern Munich's visit to Old Trafford, with an early exit in Europe sure to put more scrutiny on manager Erik ten Hag.

The Dutchman tried to argue after victory over Chelsea last week that United's season has not reached crisis-mode.

But Ten Hag's hopes that a turning point had been reached were short-lived as a 3-0 defeat at home to Bournemouth on Saturday saw a troubled campaign reach a new low.

The Red Devils sit sixth in the Premier League after seven defeats in their opening 16 games. Yet, while there may be time to

recover a place in the top four domestically, their need in the Champions League is urgent.

Only victory against the German champions on Tuesday will give United any chance of progress to the last 16 and even then, they need FC Copenhagen and Galatasaray to draw in their final Group A match.

United are fortunate to even have a shot at the knockout stages after a return of just four points from their opening five matches.

No English side has ever conceded as many as the 14 goals that Ten Hag's men have in five Champions League group games.

A series of high-scoring

shortouts in Europe contrasts sharply with United's troubles to score goals in the Premier League.

"We are really inconsistent. We have the abilities to do it, but you have to do it every game and every third day," said Ten Hag after Bournemouth celebrated their first ever win at Old Trafford in style.

"I think as a squad we are not good enough to be consistent and we have to work as a squad to improve that."

- Rashford's demise -

No United forward has scored at home in the Premier League all season as Marcus Rashford's demise has contributed to his side's struggles. Rashford scored 30 times in a career-best campaign for goals last season but has just two so far this season -- one of which came from the penalty spot.

The England international has exhausted Ten Hag's patience and been dropped for the last two games.

But Rashford could return against Bayern as his understudies have also struggled to shine.

Alejandro Garnacho has produced flashes of brilliance, though remains wildly inconsistent as can be expected for a 19-year-old winger.

Meanwhile Antony, who Ten Hag pushed to sign in a £86 million (\$108 million) deal last year, has not scored in his last 25 matches.

The Brazilian is just one of a long list of expensive flops that have seen United's fortunes decline in a decade since Alex Ferguson departed as manager.

Last weekend's loss to Bournemouth was the 35th home league defeat suffered by United since Ferguson's retirement.

During the iconic 26-year reign of the Scottish manager, United were only beaten in the league at Old Trafford 34 times.

Bayern may already be assured of their place in the last 16 as group winners but have a point to prove themselves after being thrashed 5-1 by Eintracht Frankfurt on Saturday.

And the last time Bayern lost a Champions League group game was six years ago.

United captain Bruno Fernandes said his side must "do their job" and hope for help in Copenhagen.

"We know that the next game is going to be really tough - we have to win and wait for a good result in the other game for us," said Fernandes.

"We have to do our job, first of all, but we are more than capable of getting the result in that."

Resources of some stable families are taken to support this habit and usually it is some very stable married men who delight more in this business.



indirect exchange of sexual favors to goodies and cash and the business does not differ from broad day light prostitution.

The health sector needs to just reinforce the sex protection of majors for the young people and sexually active individuals.

Economic empowerment can be a solution for the decaying moral in our society as it shall emancipate more women to stay away from prostitution business.
